" La RANDO E-Bike La Soudet "

Reserved for electric bikes



"The Pierre Jacques en barétous " named in tribute to Pierre Jacques Tillous, in remembrance of his sporting commitment and his exemplary involvement, is a public sporting event.

1 – Organization

The **16th Edition** of *the Pierre Jacques en BARÉTOUS* is organised on **Saturday 27 July 2019** in **ARAMITS** (Pyrénées-Atlantiques) by the Sports Association Barétous cycling under the guidance of the departmental Committee UFOLEP of the Pyrénées-Atlantiques (64).

The VAE is considered a hike reserved for electric bikes, the aid of which does not exceed 25 km/h

La Rando E-BIKE La Soudet : 67 kms - Dénivelé de 1500 m

2 – conditions of participation

" La Rando E-BIKE La Soudet " is open to any cyclist e-bike, male or female, of French nationality or not, licensed or not to a French or foreign Federation.

2-1: age conditions:

Only persons aged at least 17 years old on 31-12-2018 can participate in the hike " *the ascent VAE of the Col de la Pierre St Martin* ". Non-major persons on **27 July 2019** will be required to provide parental consent.

2-4 hardware and technical regulations

2-4-1: all participants in this event must wear a rigid hull helmet.

2-4-2 : electric assisted bicycles (E-BIKE) must be a pedaling cycle assisted by an electric auxiliary motor that sends its energy to the engine only to amplify the pedal movement, so proportional to the rider's strength. This is a discreet and limited assistance that does not distort the bike's primary function. The delivered power is less than or equal to 250 Watts. This device is approved for the electrical assistance to be neutralised from 25 km/h (more or less 10%), or sooner, if the cyclist stops pedaling.

Only one battery is allowed for the event with a maximum energy content of 500 watt hours.

Only the "step by step" command is allowed. Any other control (rotating throttle handle, button, trigger, etc ...) which would allow the engine to operate alone (thus without pedaling), is forbidden.

2-5: insurance guarantees

The Pierre Jacques en Barétous is a sporting event placed under the guidance of the ufolep and open to non-licensees ufolep (licensees of other federations or non-licensees), it is incumbent on the organiser, in accordance with the provisions of the sport code, to subscribe for the day all the risks inherent in their participation.

The organiser (ASB cycling – head office : Mairie 64570 aramits) and **all the participants** are therefore **covered** by the APAC (insurance sector of the education League) **in civil liability**, that is, if they create material damage and **bodily harm to a third party**. UFOLEP licensees are also covered in individual accident and repatriation assistance **by their license or the optional complementary APAC guarantees they have subscribed to**. It is up to the other participants (non-licensees UFOLEP, foreign competitors...) to subscribe on a personal basis to an individual accident insurance **to cover the damage not covered by civil liability (important example: "I hurt myself" ...)**.

Attention: the damage suffered by the bikes and cyclists outfits of the participants, either by their action or by the actions of other engaged, are not covered by this insurance (provisions not imposed by the law).



2-6: respect for the eco-cyclo Charter

"La Pierre Jacques en Barétous " has the" **eco cyclo** " label. As such, all competitors or participants must comply with the Charter.

- 1- nature is beautiful and the road is not a trash can, in all circumstances, walk, training or competition, I keep rubbish and packages waiting for the place planned to get rid of it.**
- 2- I respect the rules of the highway code, my helmet is my most loyal road Companion.**
- 3- Cycling is a wonderful sport, excellent for health, I will not spoil my chance and these moments of happiness by taking harmful and forbidden medicines.**

3 – safety

Each participant must comply with the highway code. It must use only the right side of the roadway and comply with the prefectural or municipal decrees of the communes crossed, observe the instructions given by the organizers during the race .**In the event of an infringement, each participant will be solely responsible for the accidents of which he or she is the victim.**

3-2: fees

The amount of fee includes enrolment in the village hall, lunch, personal insurance and the shower.

3-3: special conditions of registration:

Saturday , July **27** , 2019 between 6:30 a.m. and 8:00 a.m.

3-4: accompanying meals

It is possible to reserve lunch for the attendants **before July 14th**, 2019.

4 – withdrawal of registration files.

withdrawal of the bibs, at **the village Hall– place de la Mairie in aramits (64):**

-Friday **26Th** July from 16:00 to 21:00 and Saturday **27th** July from 6.30 am to 8.00 am.

5 – departures:

Group departure at the back of the timed platoon, from the Town Hall.

6 – Arrival:

Town Hall Square in ARAMITS.

7 – meals:

-**Lunch at the village hall (from 12.30 pm):** hot meal with local products BASCO-béarnais.

Other services:

Coffee and pastries for all at the start (village hall in Aramits)

Photographic report: directed by the Organization's volunteer photographers.

8 – right to image

The Organization reserves the right to use any photograph or video taken during the event in order to promote *the Pierre Jacques in barétous* (press, websites, various promotional materials). However, according to the data protection act of 6 January 1978 (CNIL), each person has a right of access and rectification to the personal information concerning him. Any participant in *the Pierre Jacques en barétous* wishing to dispose of this right is requested to confirm it in writing (by stating his name, his surname, his address and if possible his bib number) to the person in charge of the organization.
